Whereas, the work allocated to the desk of Joint Commissioner (HQ-05), Mumbai was merged to the desk of Joint Commissioner (HQ-01) vide order referred at SR. No. 02. Prior to said merger, all work related to GST Acts, notifications, circular, removal of difficulty orders, regulations and representations including related to tax rates was looked after by desk of Joint Commissioner (HQ-05). Whereas, the work related to GST rules was only assigned to desk of Joint Commissioner (HQ-01). In view of the administrative convenience the aforesaid merger was done.

Whereas, GST Council Secretariat has formed two Group of Ministers one for GST Rate Rationalization & Revenue Augmentation and other for GST System Reforms. And, the Group of Minister formed on the subject of GST System Reforms is continues as its work is ongoing. It has added to the responsibility and increased the need of more efforts in co-ordination, preparation of reports and so on. In view of this it is expedient to rearrange the administrative set up to meet the added responsibility.

Whereas, as per Government Resolution referred at SR. No. 01, the authority to allocate, reallocate the assignments / works to officers and / or internal allocation of officer to offices or location is conferred the upon Commissioner of State Tax.

Whereas, in view of the above referred facts and administrative convenience, it is expedient to further re-allocate or as the case may be re-rearrange the subjects to be handled by the desks of Joint Commissioner (HQ-01) and Joint Commissioner (HQ-05) subordinate to the Commissioner of State Tax, Maharashtra.

Therefore, I, Rajeev Kumar Mital, Commissioner of State Tax, Maharashtra in exercise of power conferred to me hereby re-allocate the work to aforesaid desks as mentioned against the desk of officers in column 3 of the annexure to this order.

Any other work / assignment not mentioned in annexure to this order shall be held as allocated to desk of Joint Commissioner (HQ-01) unless allocated to specific desk of Joint Commissioner.

This order shall be implemented immediately.
