CORRIGENDUM

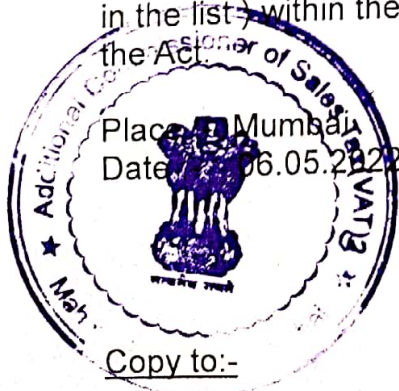
