#### NOTIFICATION

THE CENTRAL SALES TAX ACT, 1956.

No. CST. 1510/C.R. 25/Taxation-1.—In exercise of the powers conferred by sub-sections (3) and (4) of section 13 of the Central Sales Tax Act, 1956 (74 of 1956), and of all other powers enabling it in this behalf, the Government of Maharashtra is hereby pleased to make the following rules further to amend the Central Sales Tax (Bombay) Rules, 1957, namely:—

- 1. These rules may be called the Central Sales Tax (Bombay) (Amendment) Rules, 2010.
- 2. In rule 5 of the Central Sales Tax (Bombay) Rules, 1957 (hereinafter referred to as "the principal Rules"),—
  - (1) in clause (ii) of sub-rule (1), for the words "return-cum-chalan" the word "return" shall be substituted;
  - (2) after sub-rule (3), the Chalan MTR-6 appended to this notification shall be inserted.
  - 3. In Form-III(E),—
  - (1) in the heading for the words "Return-cum-Chalan" the word "Return" shall be substituted.
    - (2) the Chalan appended thereto shall be deleted.
