NOTIFICATION

Notification No. 01/2024—State Tax (Rate)

MAHARASHTRA GOODS AND SERVICES TAX ACT, 2017.

No. GST-1524 /C.R. 5/Taxation 1.— In exercise of the powers conferred by sub-section (1) of section 9 and sub-section (5) of section 15 of the Maharashtra Goods and Services Tax Act, 2017 (Mah. XLIII of 2017), the Government of Maharashtra, on the recommendations of the Council, hereby makes the following further amendments in the Government notification of Finance Department, No. MGST-1017/C.R.104/ Taxation-1[Notification No.1/2017-State Tax (Rate)],dated the 29th June, 2017,published in the *Maharashtra Government Gazette*, Part IV-B, Extra ordinary No.183, dated the 29th June, 2017, namely :—

In the said notification,—

(A) in Schedule I – 2.5%,—

(i) against S. No. 165, in column (2), for the entry, the entry “ 2711 12 00, 2711 13 00, 2711 19 10 ” shall be substituted ;

(ii) against S. No. 165A, in column (3), for the entry, the entry “ 2711 12 00, 2711 13 00, 2711 19 10 ” shall be substituted ;
