Notification No. 22/2023—State Tax

MAHARASHTRA GOODS AND SERVICES TAX ACT, 2017.

No. GST.1023/C.R.36/Taxation-1.— In exercise of the powers conferred by section 128 of the Maharashtra Goods and Services Tax Act, 2017, (Mah.XLIII of 2017), the Government of Maharashtra, on the recommendations of the Council, hereby makes the following further amendments in the notification of the Finance Department No.MGST-1018/C.R.03/Taxation-1. [Notification No. 73/2017—State Tax], dated the 29th December, 2017, published in the *Maharashtra Government Gazette*, Part-IV-B, Extra-ordinary No. 10, dated the 4th January, 2018, namely :—

In the said notification, in the seventh proviso, for the words, letter and figure “ 30th day of June, 2023 ” the words, letter and figure “ 31st day of August, 2023 ” shall be substituted.

2. This notification shall be deemed to have come into force with effect from the 30th day of June, 2023.
