MAHARASHTRA GOODS AND SERVICES TAX ACT, 2017.

No. JC-HQ-1/DC(A&R)-2/GST/Order/Area Juris-DC/2019/1/ADM-8.—In exercise of the powers conferred by sub-section (2) of section 4 of the Maharashtra Goods and Services Tax Act, 2017 (Mah.
