MAHARASHTRA GOODS AND SERVICE TAX ACT, 2017.

No. D.C. (A&R)-2/GST/PWR/JC/Sections/2017-18/ADM-8.—In exercise of the powers conferred by sub-section (1) and (3) of section 5 read with clause (91) of section 2 of the Maharashtra Goods and Services Tax Act, 2017 (Mah.
