Whereas, after the implementation of GST new registrations under MVAT & CST Act were few in number. Therefore, in view of administrative convenience, the work of processing of new registration application under MVAT & CST Act was centralized and assigned to limited officers. Accordingly, authorization for registration was given to such limited officers vide office order mentioned in the reference herein above. These authorized registration officers (MUM-VAT-C-101 & 102) are working under Joint Commissioner of State Tax, Mumbai Nodal –12. On similar line limited appellate authorities namely Joint Commissioner (Appeal) 01, Mumbai and Deputy Commissioner (Appeal) 03 were assigned for appeals related registration under MVAT & CST Act and action incidental thereto.

Now, it has been represented that members of trade face difficulties due to this arrangement. Many applicants need to travel a long distance due to existing centralized registration procedure and its related appeals. Considering changed administrative set up and trade request there is necessity to review the present centralized registration arrangement.

Therefore, I, Asheesh Sharma, Commissioner of State Tax, Maharashtra in exercise of power conferred to me hereby, authorize the officers mentioned in column 3 of Annexure to this order as Authorized Officers for processing of registration under MVAT & CST Act for their respective Divisions and the officers mentioned in column 4 & 5 of Annexure to this order as Appellate Authorities for the statutory orders related to registration and actions incidental thereto.

Necessary changes in the System shall be followed accordingly.

This order shall be implemented with immediate effect.
