Ref: Internal Circular and CBIC Circular No 182/14/2022 dt 10th Nov 2022 - Guidelines for verifying the Transitional Credit in light of the order of the Hon'ble Supreme Court in the Union of India vs. Filco Trade Centre Pvt. Ltd., SLP(C) No. 32709-32710/2018, order dated 22.07.2022 & 02.09.2022-reg.

Attention is invited to the directions issued by the Hon'ble Supreme Court vide order dated 22.07.2022 in the matter of Union of India vs. Filco Trade Centre Pvt. Ltd., SLP(C) No. 32709-32710/2018.

In the above referred circular instructions to appoint nodal officer(s) are given for proper co-ordination between central and state/UT authorities for verification of transitional credit claims.

Accordingly, following officers are appointed as Nodal Officers for the purpose of coordination with CGST authorities in their jurisdiction. The details of such nodal officers for State Tax, Maharashtra are given in following table:

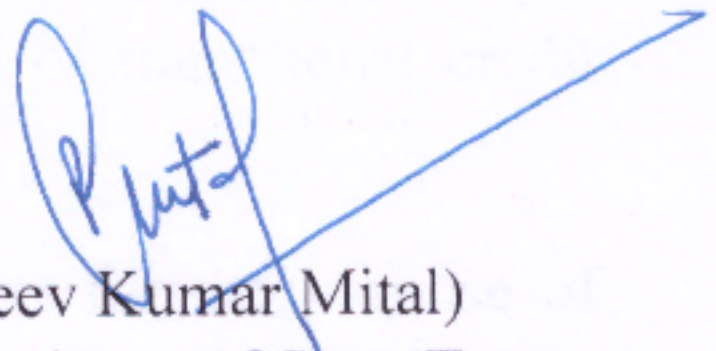

The nodal officers for Transitional Credit coordination shall ensure that the verification reports/comments sought by the jurisdictional tax officers (CGST and SGST) are being sent in a timely manner by the counterpart officers under their jurisdiction.

In case verification report/comments received from CGST officer do not pertain to the officer under jurisdiction, concerned Nodal officer shall ensure that said verification report/comment reaches the correct jurisdictional SGST officer.

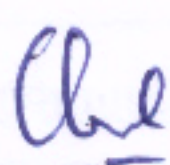
In case jurisdictional state tax officer desk shown on Back Office (BO) is different from VAT jurisdictional officer (desk), then Nodal Officer shall ensure that said request (from CGST) for verification report or comment reaches the correct VAT jurisdictional officer (desk).

The Additional Commissioner of State Tax, VAT-3, Mumbai is hereby appointed as State level officer to supervise and monitor entire work of transitional credit related work. It is the responsibility of the Additional Commissioner of State Tax, VAT-3, Mumbai to regularly monitor the state level progress made in this regard so that the timelines mentioned in the Hon'ble Supreme Court's order dated 22.07.2022 and 02.09.2022 are strictly adhered to by all the jurisdictional SGST officers and Nodal officers appointed in this behalf by this order.
