The Scheme namely "Maharashtra Criteria for Selection of Cases for Assessment Scheme, 2018" has been notified as per reference no. 1 and further amended as per notification reference no. 4 cited above, as "Maharashtra Criteria for Selection (on the basis of probable revenue earnings) of the cases for Assessment (Amendment) Scheme, 2021" and the criteria for selection of cases for assessment based on BIDW tools & other data mining tools have been devised. As per the said notification, the Selection Committee has been formed to make the recommendations in order to select the cases for assessment as per reference no. 5

By virtue of criteria given in clause 6 of the notification as per reference no.1 cited above, the cases pertaining to FY **2021-22** as per Annexure are required to be selected for Comprehensive Assessment and Issue Based Assessment.

Considering the recommendations of the Selection Committee, selection of the aforesaid cases for Comprehensive Assessment and Issue Based Assessment is necessary in the interest of revenue.

Therefore, I, Asheesh Sharma, Commissioner of State Tax, Maharashtra, as per the powers conferred upon me vide clause 7 (1) (a) of the above referred notification at sr. no. 1 hereby, accept the recommendations of the Selection Committee and accord sanction to select the cases for the period **01/04/2021 to 31/03/2022** as enumerated in the list attached with this

order in Annexure for comprehensive assessment and issue based assessment under Maharashtra Value Added Tax Act, 2002 and Central Sales Tax Act, 1956.
