4. The delivery & commissioning of All-In-One computer & Desktop pc computer should be within 8 days from the date of Purchase Order.
5. The equipment/goods must conform to the specifications given and of desired quality standards. The bidder shall guarantee that the goods delivered to the department is/are brand new and without any damages.
6. All-In-One computer & Desktop pc computer shall be supplied with necessary standard accessories.
7. Bidder shall provide 100% comprehensive on-site warranties for the supplied All-In-One computer & Desktop pc computer and Software for a period of three years from the date of commissioning of the goods/equipment are procured as a part of this contract. The warranty shall cover hardware equipment including spare parts / components, software, and other accessories if any excluding consumable items.
