Scope of Work for Supply installation and Commissioning of devices supplied:

Below is the scope of work to be conducted for successful implementation by the bidder :

- Supply, install, test, commission the UPS set;
- Supply, install, test, commission the UPS batteries in the battery racks.
- To setup and mount the 36 U Rack, complete the UPS power cabling connections till the rack from the 10 KVA UPS.
- To setup and mount the Rack server supplied in the 36 U Rack; Configure OS/ boot setup on the server.
- The SI has to provide a 5-year on-site warranty of the Server, Rack and UPS and 3 years warranty of the UPS batteries supplied along with battery maintenance service.

Terms and Conditions:-

1. Only commercial bids of complied bidders will be opened. Bidder with lowest commercial value will be considered as successful bidder.
2. 100% payment will be made to the selected bidder after successful delivery & User Acceptance Test (UAT) based on satisfactory functioning of UPS & server.
3. Successful bidder has to download licensing software (if any) from authorized site and submit the copy of same along with license to the Department.
4. The delivery & commissioning should be within 30 days from the date of Purchase Order.
5. The equipment/goods must conform to the specifications given and of desired quality standards. The bidder shall guarantee that the goods delivered to the department is/are brand new and without any damages.
6. Hardware and Devices shall be supplied with necessary standard accessories.
7. Bidder shall provide 100% comprehensive on-site warranties for the supplied devices for a period of five years for Server, Rack & UPS and for 3 years for UPS Batteries from the date of commissioning of the goods/equipment are procured as a part of this contract. The warranty shall cover hardware equipment including spare parts / components, software, and other accessories if any excluding consumable items.
8. During Warranty Period all driver software installation/up-gradation, installing patches, software bug fixes, Operating System (installation/ un-installation / upgrades etc.), troubleshooting, support and services shall also be provided on site at no extra cost.
9. During Warranty period, if any hardware & peripheral item has a hardware failure, it shall be replaced by equivalent or higher-level item by the bidder at no cost to department.
10. The Bidder shall as far as possible repair the hardware & peripheral at site.
11. In case of hardware failure, if there is a need for data recovery, the same should be done under this warranty clause at no extra cost to the department.
12. MGSTD reserves the right to accept or reject any or all the quotations without assigning any reason thereof.
13. The MGSTD will not accept any of the terms and conditions specified by the bidder separately in the quotation.
14. Currency of financial proposal shall be made in Indian Rupees only.
15. Department may terminate the procurement process at any time before giving the work order.
