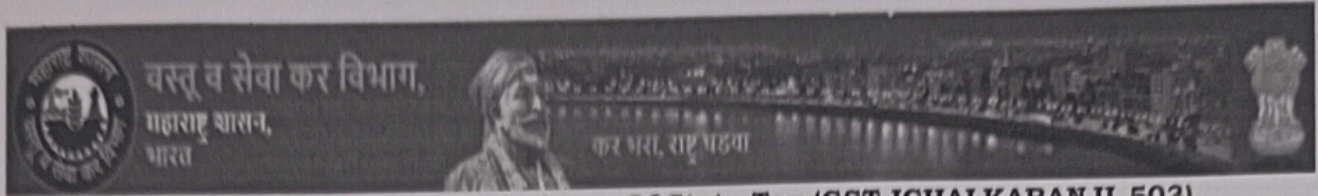
PUBLIC AUCTION NOTICE

INVITATION FOR BID IN SEALED COVER FOR AUCTION OF CONVEYANCE

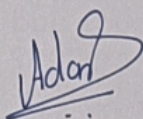
In pursuance of the Confiscation order passed by the Dy. Commissioner Of State Tax, (KOL-VAT-E-005) Kolhapur vide No:B-1162/MOV-11/2018-19, dated: 27/09/2018 under Section 130 the Maharashtra Goods and Services Tax Act, 2017, under Section 130 the Central Goods and Services Tax Act, 2017 or under Section 20 of the Integrated Goods and Services Tax Act, 2017 in FORM GST MOV-11 resulted into dues payable Rs. 10399950/- , {TAX- Rs.6316200/-[IGST- Rs.762300/- CESS -Rs.5553900/-],PENALTY-Rs.1361250/- , FINE under IGST Act- Rs.2722500/- } the driver owner/person in charge/transporter of the goods and conveyance failed to discharge the tax, penalty and fine levied within the stipulated period of time.
